



Oceanic ACC Works Information Intentions Adjustments Pacific FIR Seamless Airspace Chart

* 2013 - LQ 2014 - 1Q

During the 1ast quarter (LQ)of 2013 and first quarter (1Q), radar service was implemented in the Oceanic Control Cener, expanding their juridictional area to airways UL302 AND UL780.

* 2014 - 2Q

In the 2nd quarter (2Q) of 2014, Isla de Pascua FIR (Easter Island) upperairspace was declared as RNP10, reducing lateral separation between UPR routes, ATS routes and a combination of both to 50NM (lateral and longitudinal)

* 2014 – 3Q

In the third quarter (3Q) of 2014, technical test was started between Santiago and Tahiti, it was deferred due to software compatibily issues.

Once AIDC is fully implemented, trial will be implemented to allow iniciative DARP's, roadmap will be delivered on first quarter (1Q) 2016

Future Works Information.... Intentions Adjustments Pacific FIR Seamless Airspace Chart

* 2015 - 2-4Q

During 2015 the feasibility studies and checks for the implementation of RNP4 in Isla de Pascua FIR will be set and therefore the reduction of lateral and longitudinal separations to 30 NM.
